

Stephen Brier was founding director of the American Social History Project and co-created, co-produced, co-wrote, and/or co-edited the project's Who Built America? multimedia curriculum, which includes a two-volume textbook, ten documentary videos, two CD-ROMs, and a series of U.S. history Web sites. He has been a senior administrator at the City University of New York Graduate Center since 1998.

Michael J. Broadway is professor and head of the geography department at Northern Michigan University. His research expertise focuses on the meatpacking industry's community impacts in small towns on the Great Plains and Prairies. In 2006 he was awarded a Fulbright Research chair in the Department of Rural Economy at the University of Alberta, Canada.

Dave Burns is a doctoral candidate in history at Northern Illinois University. His dissertation, "The Radical Rites of Christ: Jesus and the Social Revolutions of the Progressive Era," explores the revolutionary conceptions of Jesus among radicals and reformers in the United States from the 1880s to the 1910s.

Barry R. Chiswick is UIC Distinguished Professor and head of the Department of Economics at the University of Illinois at Chicago. He has published seminal research in the area of the economics of immigration, testified before Congress, consulted for government agencies, and lectured on the issue at numerous academic conferences on four continents. He is also program director for Migration Studies at IZA—Institute for the Study of Labor (Bonn).

Renny Christopher is associate vice president for faculty affairs at California State University, Channel Islands. She is working on an autobiography, "A Carpenter's Daughter: A Working-Class Woman in Higher Education," which addresses her experiences as the first in her family to attend college. Before she earned her doctorate, she worked as a printing press operator, typesetter, carpenter, and horse wrangler.

Nancy Foner is Distinguished Professor of Sociology at Hunter College and the Graduate Center of the City University of New York. Her many books include *In a New Land: A Comparative View of Immigration* (2005), *From Ellis Island to JFK: New York's Two Great Waves of Immigration* (2000), and *Not Just Black and White: Historical and Contemporary Perspectives on Immigration, Race, and Ethnicity in the United States* (2004), coedited with George Fredrickson. She is chair of the International Migration Section of the American Sociological Association.

David G. Gutiérrez is professor of history at the University of California, San Diego, where he teaches courses on Mexican American history, comparative immigration and ethnic history, and the recent political history of the United States. His earlier publications include *Walls and Mirrors: Mexican Americans, Mexican Immigrants, and the Politics of Ethnicity* (1995) and most recently (as compiler and editor) *The Columbia History of Latinos in the United States since 1960* (2004).

Roger Horowitz is the author of *Negro and White, Unite and Fight! A Social History of Industrial Unionism in Meatpacking, 1930–1990* (1997) and *Putting Meat on the American Table: Taste, Technology, Transformation* (2005). He teaches food history and oral history at the University of Delaware and is associate director of the Center for the History of Business, Technology, and Society at the Hagley Museum and Library, Wilmington.

Donald D. Stull is professor of anthropology at the University of Kansas. His research and writing focus on the meat and poultry industry in North America, rural industrialization and rapid-growth communities, and industrial agriculture's impact on farmers and rural communities. He has been coeditor of *Culture & Agriculture* (1996–97), editor in chief of *Human Organization* (1999–2004), and president of the Society for Applied Anthropology (2005–7).

Daniel J. Tichenor is a research professor at the Eagleton Institute of Politics and the Department of Political Science at Rutgers University. He is the author of *Dividing Lines: The Politics of Immigration Control in America* (2002), which won the Gladys Kammerer Award for the best book on U.S. policy, and *Faustian Bargains: The Development of America's Illegal Immigration Dilemma*, which is forthcoming.
